### 1. Police Officer Recruitment Update

- a) Chandler Dean is progressing well in Field Training and begins Month two on 8/31
- b) Officer Winfrey submitted letter of resignation his last day is 8/30
- c) We currently have two vacancies and have went through our current eligibility list.
- d) One entry level in academy, one entry level in background and oral boards and chief's interviews being scheduled

### 2. ILA - Police SRO Liaison Officer for school years 2021-2022 and 2022-2023

- a) Renewing the ILA which provides the RSD with a consistent presence from Duvall Police to provide a safe environment for students and staff.
- b) The police liaison provides educational opportunities including, but not limited; drug, alcohol, peer pressure and bullying education (DARE).
- c) This agreement also accounts for compensation for after-hours event work for Cedarcrest High School, to include, but not limited to; sporting events, school dances and graduation.
- d) Looking for PSC approval to bring this to council at the 9/7 meeting.

### 3. Department Take Home Vehicle Policy Update

- a) Updating the department policy to include DMC 4.04.200: Mayor's authority to approve program.
- b) Also updating program duration (through current mayor's administration) and current tracking procedures (On weekly check-out forms)

- b) Scheduled is bagpiper, a chaplain for prayer and speech from a local representative

### 5. SGT & LT Pay Ordinance

- a) Current Ordinance 1180 relates only to Sergeants and does not address additional compensation. The police lieutenant's pay and additional compensation is in a separate contract with the City of Duvall.
- b) City Attorney has worked with finance to develop a new ordinance to clarify police
