- King County\*
  - 2018 unemployment rate 3.2%
  - 2019 unemployment rate 2.8%
  - 2020 forecasted unemployment rate 7.7%
  - 2021 forecasted unemployment rate 5.5%
- City Average property sales are up
  - 2018 average sale \$527,534\*\*
  - 2019 average sale \$485,837\*\*
  - 2020 through September average sale \$740,035\*\*
- City sales tax revenues continue to be strong despite the economic downturn

# REVENUE BIG PICTURE

- Budgeted revenues: \$47,374,426
- 44%, or \$14,370,180, higher than prior biennium mainly due to:
  - Charges for services
  - Transfers In
  - Intergovernmental Services
  - Taxes




PROPERTY TAX 2011 – 2020 ACTUAL, 2021 - 2022 ESTIMATE

### SALES TAX REVENUE 2011 – 2019 ACTUAL, 2020 - 2022 ESTIMATES






YTD SEPT 2019 TO YTD SEPT 2020 COMPARISON

# UTILITY TAX REVENUE BY CATEGORY 2019/2020 TO 2021/2022 COMPARISON







## BUILDING AND PERMITS 2017 – 2019 ACTUAL; 2020 - 2022 FORECAST




### BUILDING AND PERMITS 2017 – 2019 ACTUAL; 2020 - 2022 FORECAST WITHOUT IMPACT FEES



# OTHER NOTABLE REVENUE PART I

- Big Rock Activity Fees 25% in 2021, down \$70,000 for the biennium \$35,000 estimated for 2020
- Transportation Benefit District \$589,044 budgeted
   for the biennium \$150,000 estimated for 2020
- State Shared Revenues increasing slightly despite downturn
- Grant Revenue
  - \$4,000,000 TIB grant for 3<sup>rd</sup> Ave NE Roadway and Sidewalk Improvements
  - \$280,000 CDBG for I42<sup>nd</sup> Sidewalk Extension

# OTHER NOTABLE REVENUE PART I

- Internal Service Fund Charges for Services
  - Equipment Replacement \$351,428 more than prior
     biennium
  - Information Technology \$190,259 more than prior biennium
  - Building Maintenance \$50,728 less than prior biennium
- General Facility Charges
  - Water \$381,719 more than prior biennium
  - Sewer \$598,491 more than prior biennium
  - Storm Drainage \$40,277 less than prior biennium
